6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 1:00 pm on 2079/07/27 (13 Nov ,2022) at the office of Omsatiya Rural Municipality, Rupandehi. Bids must be valid for a period of 90 (Ninety) days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum amount 1,30,000.00/- (one lakh thirty thousands only) which shall be valid for 30 days beyond the validity period of the bid.
